1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with 24 CFR 578.7:

This planning grant will support the Mid-Willamette Valley Homeless Alliance, a Continuum of Care serving the Marion-Polk region of Oregon, through: 1) supporting staff coordination work for the region’s Performance and Evaluation Committee and PIT Count Workgroup; 2) supporting analysis and strategic improvements in System Performance Measures; 3) updating the annual services and resources gaps analysis; and 4) supporting staff and committee work in monitoring CoC- and ESG-funded providers.

Planning funds will help the CoC assure that it is carrying out the requirements of Subpart B of 24 CFR Part 578 which requires Continuums of Care to focus on provider and system performance, conduct an annual gaps analysis and PIT Count, and monitor CoC- and ESG-funded programs.

Funding from this project application will be used to coordinate the implementation of a housing and service system to prevent and end homelessness within our CoC’s geographic area by providing the CoC with essential data analysis to improve system performance, ensuring the PIT Count is using sound methodology and maximizes its outreach through collaboration and volunteer recruitment, and monitoring CoC- and ESG-funded program performance to maximum the effectiveness of HUD dollars being targeted in our local communities.

The estimated schedule for implementing the proposed activities is:

1. July 1, 2022 – June 30, 2023 – Convene monthly Performance & Evaluation Committee meetings where System Performance Measures and program-specific data are reviewed and analyzed.
2. July 1, 2022 – June 30, 2023 – Schedule and conduct monitoring site visits of CoC- and ESG-funded programs involving CoC staff and Performance & Evaluation Committee members.
3. July 1-August 31, 2022 – Prepare for FY 2022 NOFO by updating scoring tools and reviewing FY 2021 process; Performance & Evaluation Committee recommends tools for Board of Directors approval.
4. November 1, 2022-January 31, 2023 – Finalize preparations for annual PIT Count, including volunteer recruitment and organizing sites throughout the Marion-Polk region. Partner with Community Action to conduct the PIT Count. Evaluate post event and recommend improvements for the following year.
5. March 1-June 30, 2023 – Update annual gaps analysis and present it to the CoC Collaborative Committee and Board of Directors for review and comment.

CoC staff bring strong project management skills to ensure the timely start of

the project, develop a work plan with interim timeline targets, and complete tasks within established deadlines. Staff reports directly to the CoC Board of Directors.

The proposed activities will be completed by establishing and implementing the work plan. Staff meet bi-weekly to assure projects are on track and report activities and results to the board monthly.

3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

Requested funds will provide needed staff capacity to support the CoC's ability to effectively analyze data for both overall system performance and for the performance of individual CoC- and ESG-funded programs. Requested funds will also provide for staff time to convene monthly Performance & Evaluation Committee meetings and to report findings at monthly meetings of the CoC Board of Directors.

The CoC has established protocols for evaluating performance, using the local competition scoring tools as a basis for evaluation. Information from APRs, CAPERs, other HMIS reports, and site-based interviews form the basis of the CoC's evaluation of CoC- and ESG-funded programs.
