### YYA Subcommittee Collective Goals:

1. Develop a Coordinated Entry system for youth that blends into the system for adults.
2. Expand street-level and other forms of community outreach to better engage youth experiencing or at risk of experiencing homelessness.
3. Establish a Host Home program that fits the needs of the Marion-Polk region.
4. Improve local youth data, starting with the Point In Time (PIT) Count in January 2021.
5. Advocate for the use of and funding for evidence-based practices addressing youth homelessness.
6. Amplify and develop voices of youth and young adults with lived experience by creating opportunities to engage and cultivate leadership.
