Community Action’s Coordinated Entry (CE) program currently engages and serves all homeless individuals, families, Veterans, people fleeing domestic violence, and unaccompanied youth with the focus on chronically homeless individuals and participants. Utilizing information and data gathered from the VI-SPDAT, F-VI-SPDAT, and TAY-VI-SPDAT assessment tools, the program is able to assess and identify individuals service needs and vulnerabilities and connect them to housing and other homeless services.

Our program prioritizes people with the highest vulnerability for shelter opportunities, homeless resources, and housing, while utilizing a Housing First approach. Information gathered from these assessments are stored in a Homeless Management Information System (HMIS). The use of HMIS allows Community Action to measure objectives and collect and analyze data to ensure that our system is meeting the core objective of minimizing the amount of time an individual is on the streets and stabilized into permanent housing.

Utilizing a trauma-informed and low barrier approach, our program staff are able to meet with and engage individuals experiencing homelessness in Marion and Polk counties. Our Coordinated Entry program spans two counties and has helped establish, support, and maintain seven access points within the Marion-Polk region.

In addition to engaging participants through these non-barrier access sites, our team deploys trained CE Specialists and housing assessors into the field to meet with and assess individuals where they are. Our current and continuous collaboration with community organizations, school districts, law enforcement, and medical and mental health care professionals helps us reach and engage participants who might otherwise be hesitant to reach out and seek available resources. Community ActionA has a strong reputation of being able to leverage resources for and assist target populations. Community Action program staff meet regularly with community partners, organizations, and stakeholders to ensure that the needs of the community are being met and resources are being used appropriately. In addition to these meetings, our teams have utilized anonymous surveys to ensure that the needs of the individuals we served have been met. Survey results are also used to help with system improvements.

The main access site for the Coordinated Entry (CE) System is located at our Community Resource Program, ARCHES Project. Our Community Resources Program offers several programs to support individuals with varying degrees of barriers, prioritizing those with the highest vulnerability in acquiring housing. Our homeless drop-in day center is located here, which provides meals, low barrier services, and resource navigation to the unsheltered population. This site is ideal because individuals experiencing homelessness or at risk of homelessness are familiar with this location in downtown Salem, less than a half mile from the transit center.

ARCHES, in partnership with the CoC, also employs mobile assessors who are able to provide Coordinated Entry access at any location within the geographical coverage of the Marion-Polk region. The CoC Coordinated Entry Committee has also established access points throughout the region and for specific subpopulations including youth, Veterans, and people fleeing domestic violence.

ARCHES has also established a Coordinated Entry 101 training that has been presented to community partners including the CoC's Collaborative Committee to assist with educating the community about the purpose and the process of Coordinated Entry.

Community Action will collaborate with community organizations, law enforcement and fire personnel, and medical and mental health care providers to locate and meet with individuals experiencing homelessness in the community and to educate people about the Coordinated Entry Program. Community Action attends regular meetings with local Service Integration Teams, social service providers, school districts, businesses, neighborhood associations, and government agencies. Through these meetings, our staff learn about community needs and advertise Coordinated Entry with our partners. In addition to these meetings, MWVCAA hosts community engagement events providing information about Coordinated Entry and has specialists present to engage individuals with the Coordinated Entry System.

ARCHES Project maintains a social media account with over 2,000 followers with individual posts reaching on average 4,000 individuals. CE Program updates and information are routinely posted to this platform. We also maintain a database of over 500 volunteers, many of which are local politicians, legal professionals, community board members, current or retired medical professionals, and community advocates. CE Program updates are also shared to our Community Action public website, 211, radio and news outlets, and through flyer distribution.

Community Action has staff that can assist individuals with limited English proficiency. In the event that we do not have a staff member who speaks the language of the individual seeking services, we are able to utilize our relationships with community partners or contract for language support to assist the individuals we are serving.

MWVCAA has formalized and standardized an assessment process that identifies the most vulnerable people, maintains consistency in identifying individual needs, and emphasizes a person-centered approach that allows clients to have options and choices. The Coordinated Entry (CE) process makes referrals to other programs that serve homeless individuals or are at risk of becoming homeless.

Community Action is constantly educating and recruiting individuals to be a part of the CE system and providing information on how to refer homeless individuals to the CE system. Referrals can be made directly by the client, community members and partners, and staff. Participants are offered available programs within the community and assistance in navigating those resources. Resources often include access to case management, housing placement, rental/financial assistance, medical and mental health referrals and qualifying state and federal benefits including Medicaid, SNAP, TANF, SSI, and SSDI. Referrals for needed services are made the same day as the individual's enrollment into the CE system and the engagement for most services can begin same day, ensuring individuals receive as many needed services and benefits as possible in one visit. HMIS will be utilized to track referrals and outcomes, and data analysis will be used to identify gaps in resources, unsuccessful and rejected placements, and to develop plans and new partnerships to address identified gaps.
