The ARCHES Rapid Rehousing Program (RRH) is seeking a project renewal to continue serving literally homeless, chronically homeless, or fleeing domestic violence households in the Marion-Polk region. This is to be accomplished by providing housing navigation, case management, deposit assistance, and long-term rental assistance to ten (10) households. The ARCHES RRH program follows four principles in its service delivery – Housing First model, barrier removal, harm reduction, and client self-sufficiency. These principles create a community program that assists the most vulnerable populations in the Marion-Polk region while minimizing the trauma and dislocation caused by homelessness.

To access the program, clients participate in the regional Continuum of Care (CoC) Coordinated Entry (CE) system. CE allows ARCHES RRH to prioritize the most vulnerable households for immediate assistance and to identify the literally homeless, chronically homeless, or those fleeing domestic violence. CE access points are located in rural and urban communities of the Marion-Polk region, ensuring geographic equity for households referred to ARCHES RRH.

Clients are referred through CE and are assigned to a case manager upon program enrollment. A housing navigator assists with barrier removal, and then applies to the client’s preferred housing options within the Marion-Polk region. Once accepted, the unit goes through a Housing Quality Standards inspection certified through HUD. Upon move-in, household profiles are updated in HMIS to reflect the new housing status information. Subsequent service transaction data is also entered into HMIS, including financial supports.

The case manager then creates a rental assistance package, including deposit, first month’s rent, and a maximum of 24 months of rental assistance. Clients may subsidize the cost of rent based on their income and the monthly allowance of rental assistance established by HUD.

Through their enrollment, clients and case managers work together to develop a Self-Sufficiency Action Plan based on the client’s strengths and needs. This plan guides the client towards accessing and maintaining permanent housing, obtaining employment, increasing income, accessing healthcare, and obtaining social services. Case managers meet with clients at least once per month for action plan review.

Clientele who become self-sufficient, or after 24 months of rental assistance, are exited from the ARCHES RRH Program. This process includes an exit survey to determine the successes and failures of the ARCHES RRH Program, along with conducting a 6 and 12 month follow-up surveys. Using this housing placement, case management design, and follow-up metrics help ensure MWVCAA and the CoC can track HUD’s System Performance Measures: 1, 2, 4, 6, and 7.

As a renewal project, ARCHES RRH is currently operational and can quickly implement services upon grant agreement execution.


