1. Describe your organization's (and subrecipient(s) if applicable) experience in effectively utilizing federal funds and performing the activities proposed in the application.

Mid-Willamette Valley Community Action Agency (MWVCAA) is comprised of eight distinct department, all committed to ensuring individuals and families are empowered to change their lives and exit poverty through the provision of vital services. MWVCAA's Community Resource Program (CRP), commonly known as The ARCHES Project, serves people who are experiencing homelessness, housing insecurity, acute mental health crises, and inequities in accessing basic need services as well as health care and medical treatment. ARCHES accomplishes these objectives through the use of a homeless street outreach team that is funded through a variety of federal, state, and local grant funding opportunities. Outreach teams deploy throughout Marion and Polk County to meet individuals experiencing homelessness where they are and connecting them to the Regional Continuum of Care's Coordinated Entry System (CE), emergency sheltering, and Rapid Re-Housing (RRH), Transitional Housing (TH), and Permanent Supportive Housing (PSH) placements and opportunities.

Outreach staff are trained and able to assist individuals experiencing homelessness with assistance in applying for the Oregon Health Plan (OHP), Supplemental Nutrition Assistance Program (SNAP), and Supplemental Security Income (SSI). ARCHES has a partnership with JD Health and Wellness to provide medical, mental health, addiction treatment, counseling, and medication assisted therapy. JD Health and Wellness has also established a satellite clinic within our Homeless Drop In Day Center, to aid in connecting individuals to need services. Our outreach team partners with Northwest Human Services to provide immediate healthcare in the field and with Ideal Option to provide personalized, same day treatment plans for addiction to opioids, alcohol, amphetamines', and alcohol addiction. ARCHES recognizes the importance of harm reduction as a prevention tool and partners with HIV Alliance to ensure access to safe syringe exchanges and Naloxone distribution.

MWVCAA's outreach team's ability to quickly and methodically deploy to all rural and urban areas of Marion and Polk County, allowed our team to engage with 1,556 unique individuals and provide over 4,500 mobile services in the 2021 Fiscal Year. With an additional 1,100 service engagement in August 2022.

MWVCAA has experience leveraging funds from a variety of the Federal, State, local, and private sector funding streams. During fiscal year 2021, MWVCAA had an annual operating budget of \$66,216,314. From these funds MWVCAA allocated specific funding to support its housing initiates for those at-risk or experiencing homelessness. This includes: \$224,000 from the Department of Housing and Urban Development; \$20,000 from the Food Drug Administration for COVID-19 prevention and mitigation for agricultural workers; \$36.6million from Oregon Housing and Community Services for housing, shelter, barrier removal and outreach services; \$9.1million from the Department of Health and Human Services for housing, shelter, barrier removal, outreach, and benefit attainment; and \$1.86million from the City of Salem for direct client outreach supplies, emergency weather shelter utilization, and rental assistance.

In addition to these funds, MWVCAA has leveraged funding from the Oregon Health Authority in the amount of \$350,000, as well as Legacy Health in the amount of \$75,000, to assist in the development, implementation, and expansion of our migrant services outreach team. All of which is designed to provide culturally responsive services to migrant farmworkers and their families. Further illustrating that MWVCAA's diverse funding portfolio allows our organization to continue and expand services within Marion and Polk County.

3. Describe your organization's (and subrecipient(s) if applicable) financial management structure.

MWVCAA has a robust Finance department that works closely with our program directors to ensure all financial monitoring and reporting are completed in a correct and timely manner. Finance meets with the program directors to discuss the revenue and expenditure status of grants on a monthly basis. Fiscal reporting is built within Abila (a cloud based reporting software) to provide timely information to interested parties. In all, because of MWVCAA's fiduciary responsibility and efficacy the agency was able to build its overall budget for Fiscal Year 2021 to \$66,216,314. A substantial increase from the years prior. In addition to the financial management team, MWVCAA appoints a program manager for each award who is responsible for the administration of the award. This individual is designated as the Program Manager and conducts program performance monitoring to ensure target outcomes, equitable and responsible spend down of awarded funding.

As of 2022, MWVCAA remains in excellent fiduciary standing with all grant funders, including federal, state, and city. This applies to spend down, as well as monitoring. The organization has also performed more than 3 years without findings on the required annual audit.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

For the purpose of the FY22 CoC competition MWVCAA is applying for Supplemental Supportive Service Only funding to expand their Street Outreach (SO) program by 5 full time employees. This expansion will facilitate a collaboration with healthcare providers, culturally specific and LGBTQIA+ organizations to provide focus on those who have the highest service needs including those experiencing chronic homelessness and those who do not engage with traditional systems of care. Expansion will also facilitate geographic equity by growing the number of MWVCAA – SO teams serving rural and racial communities. MWVCAA - SO will be made available to Marion and Polk county communities, operating 2-3 distinct mobile teams 7 days per week, 8am-8pm.

Currently, staff conduct coordinated and comprehensive outreach providing basic need supplies, resource navigation, quick access to low barrier shelters, as well as inclement weather response. Many of which are under the MWVCAA service umbrella. Staff also facilitate access to low barrier permanent housing via the regional Coordinated Entry (CE) system by partnering CE assessors with outreach teams for field engagements, as well as navigation to a regional access sites. Our teams are made up of decision makers who have lived experience, are fluent in both English and Spanish, and are knowledgeable of an array of resources in the area. Staff have the ability to transport individuals reducing unsheltered homeless in a wide geographic area. Outreach is available throughout Marion and Polk counties, including navigating to our rural resource centers in Woodburn and Mill City. MWVCAA deploys two subpopulation specific outreach teams. The first focuses on the underserved LatinX community. The second is a Veteran specific team.

MWVCAA currently partners with JD Health and Wellness providing medical, mental health, addiction treatment, counseling, and medication assisted therapy in our sheltering locations. The current outreach model includes North West Human Services and HIV Alliance to provide targeted medical services and housing supports simultaneously. Upon execution of this proposal, JD Health has formally pledged partnering with MWVCAA – SO for mobile services targeting chronically homeless and underserved populations.

Law Enforcement partnerships are a key factor in breaking the homelessness to prison pipeline and ensuring positive outcomes for individuals who are experiencing homelessness. MWVCAA – SO has partnered with Salem Police Department to form a collaborative group that brings all of the area's service providers together to develop solutions aimed at reducing recidivism as well as effective discharge planning from institutions of care. MWVCAA – SO was recently awarded the opportunity to replicate this effort in Woodburn, OR.

MWVCAA - SO is closely tied with the local Continuum of Care through its participations in the CE, Veteran, and stakeholder committees

1a. Describe how the proposed project is consistent with the plan described by the CoC in response to Section VII.B.4 of this NOFA?

MWVCAA – SO requested funding will improve the CoC's ability to evaluate project outcomes through the expansion of full-time staff for data collection, community partner collaboration, and the identification of client needs. This will ensure that both our organization and the CoC have the necessary data to track and meet HUD SPMs. These include:

- 1)3 The number of homeless persons in the community: By having more staff dedicated to outreach, MWVCAA SO will be able to operate additional teams aimed at enhanced geographic coverage for Marion and Polk Counties. This will lead to more households experiencing homelessness identified in HMIS as well as in the ArcGIS software.
- 2)5, 6 Number of persons who become homeless for the first time or return to homelessness from housing: By increasing the amount of service engagements in the community MWVCAA SO will be able to increase the identification of households who meet these SPMs. Information will be collected and updated on HMIS on the client's profile.
- 3)7 Placement into housing from SO: By increasing MWVCAA SO presence there will be an increase in navigation to shelter, supportive services, and Coordinated Entry assessments. Thus growing the number of households who enter into placement directly as a result of their mobile and holistic efforts.

To accomplish these objectives, MWVCAA – SO will input service transaction data into HMIS. This is critical in the evaluation of service accessibility, trends, and utilization, and can be used to identify underserved populations as well as additional services needed in the community.

MWVCAA – SSO can also capitalize on the strengths of ArcGIS software when assessing HUD SPMs by aiding continuity of care and positive outcomes for individuals experiencing unsheltered homelessness. For example, as households are drawn from CE for housing placement, teams can be dispatched to the last known location of a household using the ArcGIS technology. In addition, the client profile can be updated to include information of this opportunity. So if a team member interacts with the household when in the field, they can see real-time that there is a housing placement available. In both scenarios, the use of ArcGIS can directly increase client enrollment rates, as well as successful placements into housing.

Lastly, MWVCAA – SO participates in the annual Point in Time (PIT) count by serving as a PIT Count co-chair to assist with planning development, volunteer recruitment, rural stakeholder engagement, and execution of a comprehensive plan. MWVCAA – SO also provides outreach support during the full duration of the unsheltered count, thus increasing the number of households identified. If this proposal is funded, these teams will expand allowing for enhanced geographic coverage of the CoC's district, and whereby MWVCAA – SO can commit to 100% staff engagement for the entire duration of the PIT.

5a. Describe how the street outreach project will develop a strategy for providing supportive services to those with the highest service needs, including those with histories of unsheltered homelessness and those who do not traditionally engage with supportive services.

MWVCAA - SO prioritizes unsheltered homeless individuals and households for field service engagements. Within this prioritization there are vulnerable subpopulations that are served, including: communities of color, members of the LGBTQ+ communities, individuals with disabilities, rural communities, and farmworkers. MWVCAA - SO ensures equitable access to housing, shelter, and supportive service to all of these sub-populations by using a service methodology that includes coordination with fellow outreach organizations, partnership with local law enforcement, as well as geo-mapping software and regional scheduling.

MWVCAA – SO utilizes ArcGIS, a geospatial data collection program. This program: allows community members to request outreach assistance through a ticket system, assign outreach locations via a dispatch function, as well as collect service engagement and referral data. All the while supervisors can digitally monitor and track activity; ensuring rural and urban coverage as well as monitor teams heading into high-density encampments. Benefits of ArcGIS include: real-time data of unsheltered person's location, coordination with partners, assistance with tracking referrals (i.e medical, mental health, housing), and Point in Time count coordination. From ArcGIS service reports can be created in real-time to help monitor geographic distribution of services and trends associated with need. Salem Police Department and Woodburn have pledged to partner with MWVCAA – SO in using this software when encountering unsheltered households and when needing MWVCAA - SO assistance.

With the addition of outreach staff and expansion of service deliverability and hours, MWVCAA will continue to hire LGBTQIA+ members and individuals with cultural and ethnic backgrounds to fill vacancies on our outreach team. These members will be able to utilize their personal and professional experiences to gain trust, build rapport, and assist with service navigation for the individual subpopulations. In addition to employing these methodologies, MWVCAA strives for inclusivity by hiring from diverse backgrounds, offering services in array of languages, as well as receiving input on service design from members with lived experience. As a result of a diverse staff MWVCAA is able to develop new programming targeted at providing services to traditionally underserved communities based on lived experience. An example of this is MWVCAA's Fuerza Campesina program. Through this design, MWVCAA is able to specifically enroll traditionally underserved households into Coordinated Entry, who later can be drawn into regional housing opportunities including those associated with ARCHES.

5b. Describe how project refers program participants to projects that specifically coordinates and integrates mainstream health, social services, and employment programs for which they may be eligible?

MWVCAA - SO collaborates with community partners and service providers to ensure continuity of care and wrap around services. These partnerships include medical providers, treatment facilities, shelters, law enforcement, and city code compliance. In addition to these partnerships, MWVCAA established a monthly provider meeting, bringing service providers from all scopes of work together to discuss collaborative opportunities and barrier reduction for individuals experiencing homelessness.

MWVCAA - SO has a partnership with JD Health and Wellness to provide medical, mental health, addiction treatment, counseling, and medication assisted therapy and JD Health and Wellness has established a satellite clinic within our Homeless Drop In Day Center, to aid in connecting individuals to need services. Our outreach team also partners with Northwest Human Services to provide immediate healthcare in the field and with Ideal Option to provide personalized, same day treatment plans for addiction to opioids, alcohol, amphetamines', and alcohol addiction. MWVCAA - SO recognizes the importance of harm reduction as a prevention tool and partners with HIV Alliance to ensure access to safe syringe exchanges and Naloxone distribution. MWVCAA - SO routinely works with Center for Hope and Safety, a local Domestic Violence service provider to connect survivors of domestic violence to resources. We also participate in collaborative case conference meetings and the CoC's Built for Zero initiative and work closely with Rapid Re-housing, Transitional Housing, and Permanent Supportive Housing providers to connect individuals to housing opportunities, this includes working with city and county housing authorities. Lastly, MWVCAA - SO works closely with the Department of Human services for the navigation to mainstream benefits as well as towards family reunification within their child welfare department.

4A. Supportive Services for Participants

1. Describe how program participants will be assisted to obtain and remain in permanent housing.

MWVCAA will increase the number of households into permanent housing by creating multiple access points into the region's Coordinated Entry (CE) system. This approach is also an identified System Performance Measure by HUD (Measure 7). By expanding the MWVCAA outreach team to underserved communities, there will be an increase in navigation to shelter and CE assessments, as well as supportive services for on-going successful placement. Thus growing the number of households who enter into, and remain in, placement directly as a result of MWVCAA's mobile and holistic efforts.

As the Continuum of Care (CoC) lead CE administrator, MWVCAA has the internal capacity to couple CE assessments with outreach teams. Creating a seamless partnership between mobile services and the dedicated pathway to housing services within the community. By combing CE with an expanded outreach team, there will be an increase in the number of underserved communities identified and enrolled into the CE system. This process ensures geographic, and demographic, equity for households who are then referred to CoC housing programs from CE.

MWVCAA outreach is also tasked with locating chronically homeless and medically fragile populations for placement into the ARCHES Inn. A 75 room hotel that is able to provide emergency shelter services to some of Marion and Polk counties most vulnerable individuals. Outreach teams also partner with local Housing Authorities to aid in the identification of households for emergency housing vouchers. As well as participates in the CoC's Built for Zero case conferencing system. Whereby locating clientele referred to housing opportunities using geo-mapping software and last known location data. Demonstrating that by deploying MWVCAA outreach, community housing programs will experience enhanced success outcomes for their participants.

2. Describe the specific plan to coordinate and integrate with other mainstream health, social services, and employment programs for which program participants may be eligible.

MWVCAA Outreach Coordinators operate in teams to provide basic need supplies, resource navigation to internal services (i.e ACHES Day Center for SSI/SSDI assistance and SOAR technician) as well as external providers for mainstream benefits, domestic violence referral, quick access to low barrier shelters, CE access for permanent housing, and inclement weather response.

These services are facilitated by outreach teams that travel across Marion and Polk county to engage with unsheltered individuals and households. Upon engagement, staff build a rapport with an individual. Working to understand their circumstances, barriers to housing or shelter, and needs via a triage assessment. If needed, immediate basic need supplies are provided (i.e blankets, tarps, clothing, food, water). Once basic needs are met, MWVCAA staff can then begin navigation to vital services. With the teams ability to transport, individuals can be taken directly to: area shower locations, day centers, medical appointments, shelters, housing services, inclement weather shelters, and benefit providers. This navigation practice will be enhanced by this proposal by integrating CE assessment opportunities with MWVCAA mobile teams. Further increasing the number of individuals placed into housing from unsheltered homelessness via outreach.

Lastly, MWVCAA - SO participates in collaborative meetings with regional health providers, community partners, and law enforcement. Law enforcement and Office of Emergency Management engagement is highly integrated during declared states if emergency to ensure the safety of the unsheltered community and equitable allocation of resources. Examples of this include during regional flooding, wildfire/smoke pollution, as well as extreme hot and cold external temperatures.
